He became a deacon in 1837, a priest in 1838 and subsequently served as perpetual curate to Capel Garmon, co.Denb. (9/1838 - 5/1855), vicar of Llanasa (15/4/1855 - 9/9/1860, co.Flint, and vicar of

Llanfihangel-yng-Ngwynfa (16/9/1860 - to death)
